Updates on Properties

29-31 Rhodes Circle

Lottery winners for both homes requested home inspections. Moisture in the basement was addressed with a dehumidifier. A spreadsheet for 29-31 Rhodes Circle Recommended Repairs was shared with members.

Some items requested to close include:

- Install a sink vent.
- Bring the sink drainpipe size up to code for a buyer purchase vs. the code for a rental unit.
- Repairs which will require an electrician
- Repairs require Building Inspector approval to close out permits.
- Smoke detectors need to be installed in the home at 29 Rhodes Circle.
- Remove or repair and paint water damaged drywall in various places
- Install a sump pump
- Repair a broken seal on a window by replacing a windowpane
- Treat property for termites

Requested repairs declined include a firewall in the basement in-between the units. The building is protected as a pre-existing, non-conforming structure, smoke detectors will instead be installed in each of the bedrooms at 29 Rhodes Circle.

Amended Purchase & Sale agreements will be sent to the attorneys. A professional cleaner is coming in. Members discussed whether to repair the garage door opener. Depending on the cost to repair, the intent is to repair it.
